Advisors inform about the Section for Agriculture, IBDA, and the Biodynamic associations and organizations during consultancy work and refer to the communication material provided by the Section for Agriculture, the Biodynamic associations and organizations. ### The undersigned advisors/consultants commit themselves to:

### • Continued professional development, notably in the following fields:

- $\circ$  studying the foundation of Biodynamic agriculture and the Agriculture Course of Steiner;
- training with other advisors/consultants, notably through participating in working groups to exchange about each other's' activities and experiences (national and international) and by participating whenever possible in the International Advisors' Meeting at the Goetheanum or elsewhere and stay in contact with the others advisors and the Section;
- o participating in a preparation making group somewhere;
- o participating in Biodynamic training courses of other individuals and organizations;

#### • Networking, cooperation and good professional practice:

- encouraging the individualization of farming practices according to terroir, local conditions and human know-how and consciousness;
- keeping up to date and with detailed knowledge about the Demeter standards and providing technical advice in accordance with the Demeter standards;
- getting in touch with the national Biodynamic and Demeter association or with Demeter International if there is no national association - in the countries where advisory work is being carried out;

#### • Professional ethics:

- o respecting of private and professional confidentiality of the client
- paying particular attention to working towards the self-determination and empowerment of the client;
- transferring knowledge and know-how in such a way that each client can learn the methods and act freely;
- talking freely and openly but refraining from any negative comment about other advisors or consultants, and about other points of view in Biodynamics.
- Problems should be solved directly with person affected. Conflicts or disagreements should be approached constructively and respectfully.

Biodynamic advisors and consultants who are signatories to this charter keep track of the annual improvements of this charter and agree to work in accordance with its content.
